COMMERCIAL REGISTERED OFFICE PROVIDER AGREEMENT

<u>Engagement</u>: The undersigned Company employs the law office of Bonnie G. Ostrofsky, P.C. ("Ostrofsky"), having offices at 1417 Bethlehem Pike, Montgomery County, Flourtown, PA 19031, phone number 215 233 5344, fax number 215 233 1797, to act as its Commercial Registered Office Provider ("CROP").

<u>Fee</u>: Currently, the fee for this CROP service is \$125.00 for the initial term and each renewal term. The initial fee is due at the time you sign this Agreement. Postage expenses exceeding \$10 per year, and all overnight courier expenses, will be billed to Company. If any amount due under this Agreement is not paid within 15 days after billed, a late charge of \$25 shall be due and payable immediately. If any amount owed is not paid within 30 days after billed, Ostrofsky may terminate this service, and Company shall be responsible for the CROP termination filing fee, if any and all costs of collection of amounts due from Company and the individual signing below.

<u>Term and Renewals</u>: The initial term of this agreement shall commence on the later of the filing or effective date of the document for which you are using Ostrofsky as your Commercial Registered Office Provider, and end 11 full calendar months after the commencement month. (So if the document filing date is 6/15/08, the first contract year would be 6/15/08 through 5/31/09.) This agreement will automatically renew for additional one year terms until either Ostrofsky terminates her CROP services, or you notify Ostrofsky you no longer need her services and provide evidence that Ostrofsky is no longer identified as your CROP. Ostrofsky will notify you at least 30 days in advance of your renewal date of any termination or change in terms of this agreement. If you don't send her a termination notice prior to the end of the current term, this agreement will automatically renew at the terms set forth in her renewal notice.

Services provided: During the term of this agreement, you have the right to specify Ostrofsky as your CROP on Secretary of State filings by your Company. Ostrofsky agrees to forward by United States Postal Service first class mail, to the address set forth below or such other address as Company provides in writing to Ostrofsky, all mail received by Ostrofsky, except correspondence which is clearly junk mail (it being understood that the term "junk mail" includes unsolicited charge card applications). Ostrofsky may open (but has no obligation to open) any envelope received to verify whether it is legitimate mail or junk mail. If requested in advance by Company, Ostrofsky will forward to Company by overnight courier (at Company's expense) any documents received in a legal action involving Company. Company is responsible for notifying Ostrofsky in writing of any change of address.

<u>Limitations</u>: Ostrofsky is not liable if properly forwarded mail is not delivered by the USPS or other courier to Company. Company is responsible to prepare and file the forms creating their entity, amending such filings, or changing their registered office. Such services are available from Ostrofsky at an additional fee, upon request, but are NOT included in this CROP Agreement.
